## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- SEC. 3107C. (1) AN AUTOMOBILE INSURER SHALL PAY FOR SERVICES

  COVERED UNDER SECTION 3107(1)(A) THAT ARE PROVIDED BY A HOME HEALTH

  AGENCY TO AN INJURED PERSON IF ALL OF THE FOLLOWING ARE MET:
  - (A) THE SERVICES ARE ORDERED BY A HEALTH PROFESSIONAL ACTING WITHIN THE SCOPE OF HIS OR HER LICENSE OR CERTIFICATE.
  - (B) THE SERVICES ARE PROVIDED TO THE INJURED PERSON IN HIS OR HER HOME OTHER THAN A HOSPITAL, NURSING HOME, OR COUNTY MEDICAL CARE FACILITY.
  - (C) THE HOME HEALTH AGENCY IS ACCREDITED BY AN ACCREDITATION ORGANIZATION RECOGNIZED AND UTILIZED BY THE FEDERAL MEDICARE
